This is with reference to Hon'ble Supreme Court's order dated 30.10.2015 in WP (Civil) No. (s) 55/2003 and 572/2003 regarding implementation of Scheme of Shelters for Urban Homeless (SUH), a component of National Urban Livelihoods Mission (NULM). A copy of the order dated 30.10.2015 is enclosed.

2. Hon'ble Court has directed this Ministry to file an affidavit indicating the State-wise distribution of the amount attributable to urban homeless under SUH component of NULM. This Ministry has also been directed to file an affidavit in the form of a composite chart indicating the date of completion of the proposals that have been sanctioned or approved by the State Governments/Union Territories and the estimated expenditure to be incurred in the new construction or refurbishment of shelters for urban homeless. The number of shelters for urban homeless that are planned for each State/Union Territory is also required to be indicated.

3. The Hon'ble Court has further directed that, in spite of several orders passed in the matter, there has been inadequate compliance. Taking a serious note of the matter, Hon'ble Court has further directed that in case the State/Union Territories do not respond to the request made by the Ministry, the Court may have to summon the Chief Secretary of the concerned State/Union Territory so that the facts are made available to the Hon'ble Court on affidavit.

4. As the Hon'ble Court has specifically asked for audit of NULM funds, it is requested to complete the audit of NULM funds released during 2014-15 at the earliest and submit the audit report to the Ministry.

5. In view of the above, formats for furnishing the information that would be required for filing the affidavit in Hon'ble Court are enclosed as Annexure -I, II, III and IV. As this Ministry has to file an affidavit within four weeks, you are request to please furnish the information to this Ministry latest by 12.11.2015.
