- 4. Bank guarantee of 5% of the work order value is to be deposited within 7 days from the date of issue of letter of first visit.
- 5. Any changes in the policy or guidelines by Govt. of India or Govt. of U.P. will be binding on the consultant.
- 6. Mission Director (HFA) / Director SUDA has the sole right to issue further directions as required.
