The body shall be of good quality metal and the roof shall be of fiber glass or a combination of fiber glass and metal of good quality. Please clarify that FRP Body is not approved/allowed and material for vehicles to be supplied under this Tender. 10	Windshield shall be made out of laminated safety glass. Wiper shall be electric motor operated. Front windshield shall confirm to IS: 2553 Test Standard.
